

## **GENDER RECOGNITION LEGISLATION IN HONG KONG: OPPORTUNITIES AND CHALLENGES**

The Hong Kong government is currently considering options for relevant legislation in response to a 2013 Hong Kong Court of Final Appeal judgment on transgender marriage (W v The Registrar of Marriages). After the court's decision, the government established an Inter-departmental Working Group on Gender Recognition (IWG) which has recently produced a Consultation Paper examining different types of gender recognition schemes and possible arguments for and against the adoption of particular models for Hong Kong.

In order to contribute to this exercise, The Centre for Comparative and Public Law and its Human Rights Programme, in collaboration with the Hong Kong Equal Opportunities Commission, are hosting a forum with professional and academic experts and advocates, including members of Hong Kong's transgender community, to discuss the Consultation Paper. The outcome of the event will be submitted to the IWG and thus inform and hopefully positively contribute to a possible future Gender Recognition scheme.

## PROFESSOR STEPHEN WHITTLE

Manchester Metropolitan University, UK



STEPHEN WHITTLE OBE, PhD, DLaws hc, FAcSS, MA, LLB , BA is Professor of Equalities Law at Manchester Metropolitan University.

In 1975 Stephen set up the UK's first local

trans support group in Manchester, and transitioned to living as Stephen. Having lost many jobs because of being trans he decided things would only change if trans people understood the law. After qualifying in law in 1990 and in 1992, Stephen became a co-founder of Press For Change (PFC), the UK's transgender lobbying group. PFC fought cases at the European Court of Justice and the European Court of Human Rights to gain legal recognition for Trans people in the Gender Recognition Act 2004. In 2010, PFC also achieved full protection for trans people under the UK's Equality Laws.

Stephen has been an advisor to the UK, Irish, Italian, Japanese and South African governments, the Council of Europe and the European Commission. He advises lawyers, regularly writes court briefs, or is an expert witness in courts across the world. In 2015, he was appointed special advisor to the Parliamentary Women & Equalities Committee Inquiry into Transgender Equality. Stephen has received many awards for his academic and voluntary work, including a Lambda Literary Award as co-editor (with Susan Stryker) of "The Transgender Studies Reader" and The Stonewall Award from the American Bar Association in recognition of his contribution to "removing barriers and championing diversity for the LGBT community, both within the legal profession and impacting the greater human universe." In 2005, he was made an Officer of the Order of the British Empire (OBE, 2005) in the Queen's New Year's Honours list for his work with the British Government on transgender rights. In 2016, he was elected a Fellow of the Academy of Social Sciences.

Stephen and his wife Sarah married in 2005 after Stephen gained legal recognition as a man, but have been partners for 39 years. They have 4 children.
